WHO CAN SIGN FOR ACADEMIC INSTITUTIONS:

LICENSE AGREEMENT

IMPORTANT - READ BEFORE INSTALLING

Read this agreement carefully before installing the IBM Design Kit (hereafter Design Kit). This letter Agreement between International Business Machines Corporation, a New York corporation, having a place of business at Essex Junction, Vermont (hereafter IBM) and You, if accepted by You, represents a Program License and Loan Agreement for the referenced Design Kit. By installing the Design Kit, You accept the terms of this Agreement. If you do not accept the terms of this Agreement, do not install the Design Kit, and please return to IBM this letter and any software or documentation received.

You and IBM agree that the following terms and conditions will apply to the Design Kit licensed under this Agreement. This is a license agreement and not an agreement for sale. IBM retains title to the copy of the Design Kit provided to you and any copy made from it

This Design Kit is being distributed by the University of Southern California located in Marina del Rey, CA ("USC").

DEFINITIONS

The term "Design Kit" means: any machine readable instructions or statements, any machine readable data base, and/or any machine readable or printed related materials, including documentation and listings provided by IBM; all copies of such Design Kit, including portions of such Design Kit; and

all updates or derivatives of the Design Kit.

The term "Use" when referring to the machine-readable portion of the Design Kit, means copying any portion of the Design Kit into a machine for processing, transmitting it to a machine for processing, and performing such processing.

The term "DK Derivatives" means any designs created using the Design Kit.

LICENSE

The Design Kit is provided to You as an IBM customer solely for Your Use. IBM hereby grants to you a non-exclusive, non-transferable, revocable, limited license to use, perform, display and make copies of the Design Kit, solely and exclusively in accordance with this Agreement.

You may

use the Design Kit solely for (i) the evaluation of the Design Kit for determining whether or not to design a product to be manufactured solely by IBM, or (ii) the design of products to be manufactured solely by IBM.

copy or translate the machine readable portion of the Design Kit into any machine readable or printed form to provide sufficient copies only to support your licensed Use as well as reasonable storage and backup of the Design Kit, and copy the printed materials to support Your licensed Use.

You may not

reverse assemble or reverse compile the Design Kit;

distribute the Design Kit to any other persons, including other licensees; and

use, copy, modify, or transfer the Design Kit, except as expressly provided for in this Agreement.

SUPPORT AND SUBSEQUENT RELEASES

IBM will not provide support for this Design Kit. IBM may make a subsequent Design Kit release available to You for Your use.

PROTECTION AND SECURITY

You hereby agree that both the Design Kits themselves and any information added by the Design Kit to Your physical design shall be considered IBM confidential information. For avoidance of doubt, You hereby recognize and agree that DK Derivatives shall include such IBM confidential information.

You hereby agree that for five (5) years after the date the Design Kit is disclosed to You that You will protect the confidentiality of the Design Kit and the IBM confidential information contained in the DK Derivatives.

For purposes specifically related to Your licensed Use of the Design Kit, You and USC can exchange DK Derivatives.

You will take appropriate action, by instruction, agreement or otherwise, with any person, to satisfy your obligations under this Agreement.

You will reproduce and include the copyright notices and any other legend on any copies, modifications, or portions merged into any other Design Kit.

You will maintain records of the number and location of all copies of the Design Kit.

You will insure, before disposing of any media, that any Design Kit contained on it has been erased or destroyed.

Except as expressly provided for in this Agreement, You agree that You will not make IBM Confidential materials available to any third party.

For purposes specifically related to Your licensed Use of the Design Kit, You may make the Design Kit available to any of the following: (1) Your subsidiaries who are more than fifty percent (50%) owned or controlled by You ("Subsidiaries"); (2) employees of You or Your Subsidiaries; (3) Subcontractors of You or Your Subsidiaries; and (4) IBM's employees (a) during the period they are on Your premises, or (b) whom You authorize to have remote access to the Design Kit. For purposes of this paragraph, "Subcontractors" shall mean, and shall be limited to, those persons who are contractually engaged full time on a temporary basis by You to perform the same semiconductor device design services as Your regular employees who have rightful access to the Design Kit(s) hereunder and who perform

such services only on the premises of You or Your Subsidiaries

TERM

The license granted herein is effective for a period of three (3) years after you install the Design Kit. This license may be renewed upon your written request and IBM's written approval.

You may terminate this agreement at any time by destroying the Design kit together with all copies, modifications and merged portions in any form. It will also terminate upon conditions set forth elsewhere in this agreement or if you fail to comply with any term or condition of this agreement. You agree upon such termination or expiration to destroy the Design kit together with all copies, modifications and merged portions in any form.

PATENTS AND COPYRIGHTS

If the operation of the Design kit becomes, or IBM believes is likely to become, the subject of a claim that it infringes a patent or copyright in the United States, you will permit IBM, at its option and expense, either to secure the right for you to continue using the Design kit or to replace or modify it so that it becomes noninfringing. However, if neither of the foregoing alternatives is available on terms which are reasonable in IBM's judgment, you will return the Design kit to IBM upon IBM's written request. IBM will have no obligation with respect to any such claim based upon your modification of IBM equipment, Design Kit or programming or their combination, operation or use with any non-IBM apparatus or programs. SHOULD THE DESIGN KIT PROVE DEFECTIVE, YOU (AND NOT IBM OR AN IBM AUTHORIZED REPRESENTATIVE) ASSUME THE ENTIRE COST OF ALL NECESSARY SERVICING, REPAIR OR CORRECTION.

You agree to comply with all United States and foreign laws and regulations relating to the export of technical information or data.

In the event of the termination or expiration of this Agreement, any provisions of this Agreement which by their nature extend beyond the expiration or termination date shall remain in effect until fulfilled.

This Agreement will be construed under the laws of the State of New York, without regard to its conflict of laws. The parties hereby expressly waive any right they may have to a jury trial, and hereby consent to the exclusive jurisdiction and venue in New York courts.

THE PARTIES ACKNOWLEDGE THAT THEY HAVE READ THIS AGREEMENT, UNDERSTAND IT, AND AGREE TO BE BOUND BY ITS TERMS AND CONDITIONS. THE PARTIES FURTHER AGREE THAT THIS AGREEMENT IS THE COMPLETE AND EXCLUSIVE STATEMENT OF THE PARTIES AGREEMENT. THIS STATEMENT OF THE AGREEMENT SUPERSEDES ALL PROPOSALS OR OTHER PRIOR AGREEMENTS, ORAL OR WRITTEN, AND ALL OTHER COMMUNICATIONS BETWEEN THE PARTIES RELATING TO DESIGN KITS LICENSED UNDER THIS AGREEMENT. THE AGREEMENT MAY ONLY BE AMENDED BY A WRITING SIGNED BY

BOTH PARTIES SPECIFICALLY AMENDING ITS
TERMS.
